- (3) Use whilst drawing a greater number of trailers than is permitted by Law.
- (4) Use to secure the release of any motor vehicle which has been seized by or on behalf of any government or public authority which was not the property of the Policyholder or in the Policyholder's custody or control at the time of seizure.
